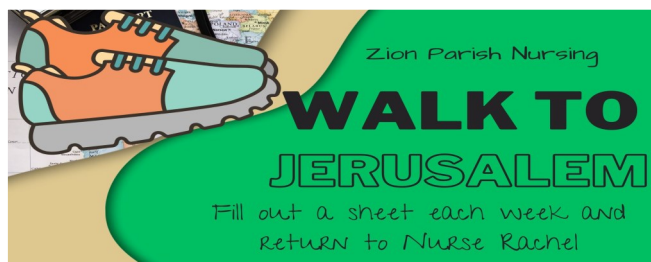
AS WE GATHER: Our Bible Reading of the Day are Acts 20:1–12; 2 Corinthians 11:22–28. After an extended stay in Greece, Paul sets off on another journey, finally arriving in Troas. There, as he preaches late into the night, a young man named Eutychus falls asleep on a window ledge and tumbles three floors to his death. Paul rushes to his side and restores Eutychus to life. Later, in his second letter to the Church at Corinth, Paul recounts in detail the numerous hardships he endured in his ministry.

The Zion Foundation was created in 1986 as a separate nonprofit entity whose mission is to provide financial support for the missions and ministry of Zion Lutheran Church.
